

ELIGIBILITY & PRESENTATION

REQUIREMENTS

Open to all local or national artists 18+ years. Original fine art in any medium is acceptable. No videos or reproductions. Original 2-D/3D only. Works on paper 24" or larger in the long dimension must be framed behind plexiglas. **Clip mounts will not be accepted.** Works on canvas may be wrapped around stretchers if painting extends along the sides. Stretchers must be at least 1" deep. Work that is wet will not be accepted. Maximum framed size not to exceed 30" x 40" or 72ui. All two-dimensional works must be ready for hanging **with hooks and wire.**

THREE-D WORKS

May be exhibited on the floor or pedestal, depending on size. You may provide your own pedestal. No work should exceed **50 lbs.** Work that is too difficult to install will be excluded. You may submit several views.

ENTRY METHOD

Entry Fee is \$35 for up to three works. Additional works, \$10 each. Jurying will be from digital images. CD's must be labeled with artist's name (last name first), titles, and medium. Digital images should be 72 ppi, RGB jpeg format with maximum 600 pixels in any one dimension. File names should be artist's last name followed by title. Example: JonesBlueSquares. Acceptance of any digital entry is contingent on seeing the real object.

SHIPPING

Note that Gallery West has no storage space for receiving, unpacking, storing packing material, or re-packing/shipping accepted work from artists too distant from Alexandria to hand deliver accepted work. Therefore we use a local shipping service for these functions, at an additional handling fee, \$15.00 each way, paid to the shipping service, by the artist, plus the cost of shipping. JUROR

F. Lennox Campello is one of the Mid Atlantic's best known arts personalities. Educated in art at the University of Washington School of Art, Campello is an award-winning artist, a widely published freelance art critic, and a curator with more than one hundred curated exhibitions under his belt. A radio and TV personality, he is often heard on NPR, the Voice of America and MHZ TV's "ArtsMedia News" discussing art issues as a former and charter Associate Dealer for Sothebys.com and one of the internet's seminal visual arts bloggers. His Daily Campello Art News (www.dcartnews.blogspot.com) is one of the web's earliest and most popular art blogs with nearly a million visitors a year. Campello is also the co-founder of the Fraser Galleries of Washington, DC and Bethesda, Maryland, which he co-owned for ten years until 2006. His work was recently selected by well-known art collector Mera Rubell for the "Cream" auction at the Katzen Art Museum.

All work must be for sale. Gallery West will retain a commission of 40%. Works may not be removed before the end of the exhibition.

AWARDS

Awards totaling \$1000, to be determined by the juror.

PLEASE READ CAREFULLY

Entries must be received by November 12. Late entries will not be juried and entry fees will not be returned. Please mail early.

All accepted work must be for sale and must match the submitted images and entry form characteristics, including sale price. No accepted work may be removed before the end of the show period. Submitted JPEGs may be used for exhibition publicity purposes, including posting on the Gallery West web site.

Reasonable care will be taken to ensure the safety of digital entries and artwork. However, Gallery West will not be liable for any damage or loss during the jurying, delivery, exhibition, removal or return shipping of art work.

Accepted artists who ship their work to Alexandria VA. for the exhibition must ship to the shipping service prescribed in the acceptance notification letter, and pay a handling fee to said shipping service. Artists who ship work for the exhibition are responsible for all costs incident thereto, including insurance expenses and return shipment if the piece does not sell. Gallery West will not accept nor be held liable for any work damaged in shipment.
